DID YOU KNOW ...?

- 61% of households have a pet and there is an estimated 5.1 million dogs and 3.8 million cats in Australian households
- Of pet owners[1], approximately
 - o 94% are likely to be concerned about puppy farms and unscrupulous breeders
 - o 93% are likely to be concerned about the abandonment of pets
 - o 66% are likely to be concerned over the high euthanasia rate of cats
- Pet owners are likely to say[1]:
 - their pets are part of the family (90%)
 - o pets give them great comfort in times of need (80%)
 - they talk to more people because they have a pet (80%)
 - they make holiday choices based on pet friendly accommodation (55%)
