MTC COMMUNITY ART COMPETITION – JUNE 2022

Terms and Conditions

- By participating in the Competition, the Participant agrees to these Terms and Conditions.
- Entries must be the entrant's own original work and must not contain any objectionable, • profane, insulting, inflammatory or defamatory material, or infringe a third party's intellectual property.
- Entrants using images containing people, including children, that can be identified must • provide a release form for each person identified. The release form must be provided to have images used for the purpose of the competition and subsequently by Melton City Council. Release forms for children must be signed by a parent or guardian.
- Entry is restricted to people who live, work, study, or volunteer in Melton City Council. • Entrants must not be professional artists or photographers. For the purposes of this competition, a professional artist or photographer is defined as someone who holds themselves or represents themselves in any way, including on social media, as being a professional photographer or artist.
- Winners will be announced at the Lifelong Learning Festival launch on Saturday September 3, 2022.
- The judge's and Council's decision is final, and no correspondence will be entered into.
- All prizes are to be collected by Monday September 19, 2022. If prizes are not collected by this date, the winner will forfeit the prize.
- Shortlisted entrants must pick up their artwork from the Melton Central Community Centre • by Monday September 26, 2022. If for some reason you are unable to retrieve your artwork, you must contact the Council officer managing the competition and make appropriate arrangements. If works are not picked up by this date, they may be discarded.
- Employees of Melton City Council and their immediate families are welcome to enter the competition. All artworks submitted will be judged anonymously. The artwork must not be able to identify the artists.
- Melton City Council (and Council authorised third parties) reserve the right to use • photographs of the artworks for various media formats including, but not limited to, print media, including Council publications advertisements, calendar, websites, social media and other digital mediums, and for display purposes.
- Entrants will be credited during the display, and if the artwork is reproduced at any time. •
- The Melton City Council has no liability, in negligence or howsoever, for any accident, loss, illness, injury, damage, or inconvenience suffered by you or any individual or property arising out of or after entering the competition or collecting and using the prize.
